

## Contract for Use of Pinerock French Bulldogs Stud

### DEFINITION OF "LITTER"

A Litter, for the purposes of this Contract, is defined as a minimum of 2 puppies born and alive with no cleft pallet. (Cleft pallet puppies do not count towards the number nor will they be registered) If Breeding does not result in pregnancy, or only one puppy is born alive, a Repeat Breeding will be given to the same Bitch on her next season. If the Bitch fails to conceive on the return service, Bitch owner agrees to run a vaginal culture on her next heat in order to receive a third stud service, if Bitch fails to conceive a third time this Contract is terminated, unless otherwise agreed upon by both parties. If other arrangements have not been made with the Stud Dog Owner(s) and the Bitch is not bred on her next season, or is bred to another Stud Dog on her next season, the stud fee is forfeited and the Contract is null and void.

### RE-BREED CONDITIONS:

A rebreed may be used toward any male of your choice or if the stud that was used is no longer available. The stud fee may be applied toward any of Pinerocks studs but no refunds will be given if there is a difference in value.

(Example #1- Stud fee for "Stud A" is 5000 for rebreed client wants to use "Stud B" for 3500- there will be no refund for the difference)

(Example #2- "Stud A" fee 5000 "Stud C" the stud fee 10,000- stud owner will collect the difference of 5000 before the re-breed takes place)

### STUD DOG OWNER AGREES TO:

- 1) Provide a three-generation pedigree of the above-named Stud Dog;
- 2) Sign Litter Registration promptly
- 3) Allow bitch owner to use any photos/video of Stud dog for their advertising of this litter
- 4) Send bitch owner results any requested health testing that has already been completed for the stud

### BITCH OWNER AGREES TO:

- 1) Notify Stud Dog Owner in writing, no later than 63 days after Breeding, if no pregnancy results from the mating. Failure to do so will result in no return service being provided;
  - 1) If breeding does not result in pregnancy- Bitch owner is to provide veterinarians phone number so they are able to confirm that there was no pregnancy. If no puppies are present on ultrasound, Bitch owner agrees to run an X-ray on day 60 to confirm- microchip of bitch must be present on Xray.
- 2) Keep the Bitch properly confined following Breeding to ensure no other Dog could mate her accidentally before her season is complete;
- 3) Pay any and all veterinary and financial arrangements, including, cost of shipping, collection, semen box, etc.

4) Agrees to disclose the Bitches proper DNA, should the Bitches DNA be different than what is written above- Bitch owner understands stud fee may be higher to reflect that change.

I understand the above written Contract and agree to abide by all sections both typed and written. Both parties agree to all of the above agreements and terms.
